## **About Cookies**

A cookie is a small file which asks permission to be placed on your computer's hard drive. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

There are two main kinds of cookies: "session" cookies and "persistent" cookies. Session cookies only last for the duration of users using the website and are deleted from your computer when you close your browser, whereas persistent cookies outlast user sessions and remain stored on your computer until deleted, or until they reach their expiry date.

## **Cookies on this Website**

We use cookies for the following purposes:

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.

## **Third Party Cookies**

We also use third party cookies. Third party websites and service providers, such as YouTube, Vimeo, Facebook, Instagram, X (Twitter) and Google Analytics, may send you cookies. We do not control the setting of these cookies, so we suggest you check the third party website for more information about their cookies and how to manage them.

Third party cookies may be used for the following purposes:

- to track your browser across multiple websites;
- to build a profile of your web surfing;
